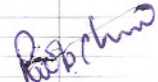

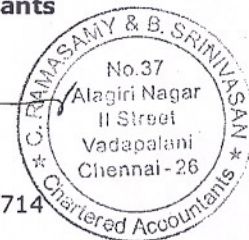
Limited Review Report
