INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM FINANCIAL RESULTS

TO THE BOARD OF DIRECTORS OF BETALA GLOBAL SECURITIES LIMITED

 We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of BETALA GLOBAL SECURITIES ("the Company"), for the quarter ended 31st December, 2021 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.
